## Government and Public Affairs

There has been activity regarding the Surgical Technologist Certification bill. The bill was filed in September with the Oregon State Legislative Council, (LC). Since the filing, there have been several discussions regarding the bill and the wording of the bill. Just recently the bill was released from the LC office, AST, as well as our President Catherine Reid and I have reviewed the bill. We have found some errors in the rewrite of the bill, which we hope to get corrected before the session starts in January. Once the bill is corrected and we have the bill number, this information will be posted on our OAST website at <http://oregon.ast.org>. After opening the website, just go to the upper left corner and hover the mouse over Home, then click on Government and Public Affairs, you will see several forums there which will help bring you up to date with the activity of the bill. Please check this website frequently for updates, we have found this to be the quickest way to get the information out to the members.

Since the meeting on November 6<sup>th</sup>, the election has taken place and we came very close to losing our Senate sponsor, Senator Bates but after the final count he was declared the winner for his district.

We have several more meetings coming up before the first of the year and even more once the session starts. These meetings are to educate other organizations, legislators and the public as to what the bill entails and answer questions regarding this very important piece of legislation.
